

## Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.brandpartnerscollective.com](http://www.brandpartnerscollective.com) and BrandPartners Collective and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to BrandPartners Collective include [www.brandpartnerscollective.com](http://www.brandpartnerscollective.com), BrandPartners, Melis +Dainon and [www.melisdainon.com](http://www.melisdainon.com). The BrandPartners website is a branding, marketing, and consulting site. By using the BrandPartners website, you consent to the data practices described in this statement.

### Collection of your Personal Information

In order to better provide you with products and services offered, BrandPartners may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase BrandPartners products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. ### Use of your Personal Information

BrandPartners collects and uses your personal information to operate and deliver the services you have requested.

BrandPartners may also use your personally identifiable information to inform you of other products or services available from BrandPartners and its affiliates.

### Sharing Information with Third Parties

BrandPartners does not sell, rent or lease its customer lists to third parties.

BrandPartners may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to BrandPartners, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by BrandPartners. ### **Use of Cookies**

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**
